The following Resolution was offered by Director Ron Villamaria and seconded by Director Amy Wojciechowski:

## RESOLUTION APPROVING PRELIMINARY ASSIGNED PARTIAL FUND BALANCE FOR FISCAL YEARS 2024- 2025, 2025- 2026 and 2026-2027

WHEREAS, the Michigan Great Lakes Virtual Academy Board of Directors recognizes the need to designate the proper uses to assign the partial fund balance for the fiscal years 2024-2025, 2025-2026 and 2026-2027.

WHEREAS, the estimated fund balance for fiscal year (2022-2023) is Seven Million Seven Hundred One Thousand Five Hundred Sixty Two and 79/100 Dollars (\$7,701,562.79) and the projected non-restricted expenditures for fiscal year (2022-2023) is Thirty One Million Seven Hundred Ninety Three Thousand Five Hundred Twenty Nine and 00/100 Dollars (\$31,793,529.00).

WHEREAS, the adopted fund balance allows for adjustments of assigned balances prior to the final audit.

## NOW, THEREFORE BE IT RESOLVED:

- 1. The Board of Directors hereby approves this Preliminary Assigned Partial Fund Balance for fiscal years 2024-2025, 2025-2026 and 2026-2027, as follows:
- a. Two Million Two Hundred Ninety-Five Thousand Six Hundred and 00/100 Dollars (\$2,295,600.00) assigned over three (3) fiscal years (2024-2025, 2025-2026 and 2026-2027) to retain both certified and non-certified staff positions to provide interventions to support students in learning loss and to provide classroom size reductions.
- b. Two Million Six Hundred Twenty-Eight Thousand Three Hundred Eighty-Eight and 00/100 Dollars (\$2,628,388.00) assigned over three (3) fiscal years (2024-2025, 2025-2026 and 2026-2027) for expenses related to staff and programs to provide students with social and emotional support.

- c. One Million and 00/100 Dollars (\$1,000,000.00) assigned over three (3) fiscal years (2024-2025, 2025-2026 and 2026-2027) for expenses related to state testing and benchmark assessments for MGLVA students.
- d. No individual may make adjustments to the above listed dollar amounts and purpose(s) for which the preliminary assigned fund balance funds will be used without Academy Board approval.
- The remainder of the Michigan Great Lakes Virtual Academy Fund Balance shall remain in the Academy Fund Balance until/unless assigned/committed by the Academy Board.
